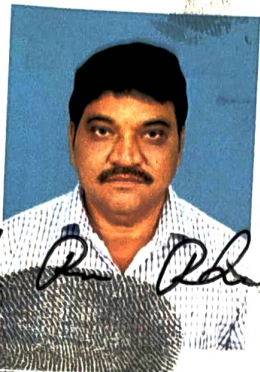

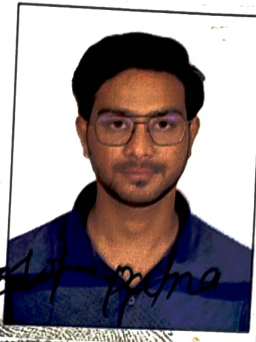

NOW THIS INDENTURE WITNESSTH AS FOLLOWS:

1. SETTLEMENT

The party of the first part, the SETTLOR, does hereby settle the sum of Rs 10,000/- (Rupees ten thousands only) in TRUST (Hereinafter referred to as the TRUST FUND). With the name and for the objects hereinafter stated, by delivering the said amount in cash which the party of the other part, the TRUSTEES, have accepted the receipt of which they do hereby acknowledge to hold the same in and to the TRUSTEES with the powers and obligations as provided hereinafter.

2. NAME AND PLACE OF OFFICE.

The name of the TRUST shall be

"KOSHAL BHARATI BIDYAPEETH AND CHARITABLE TRUST"

The principal office of the Trust shall be situated at Attabira, Dist- Bargarh or such other place as the Trustees may decide from time to time. The Trust may also carry on its work at any other place or places as decided by the Trustees.

3. TRUST PROPERTY, TRUST FUND

- 3.1. That the "Trust Property" includes the schedule property as well as all other property: movable and immovable and moneys that the Trustees may receive from the SETTLOR or any other person or otherwise hold, by way of purchase or any other mode of acquisition or by way of donations or gifts or by way of interest accrued on the Trust property, dividends or Shares, rents or other income and other accumulations howsoever made and other investments representing the Trust property for the time being and from time to time existing.
- 3.2. That the Trustees may accept donations, grants, subscriptions, aids or contributions from any persons, Government, local authorities or any other Charitable institutions in cash or in kind including immovable property without any encumbrance, but the Trustees shall not accept any receipt with any conditions or terms in consistent with the object of the Trust. While applying such receipts to the object, the Trustees shall respect the directions if any by the grantor. Any receipt with specific directions to treat the same as part of the corpus of the Trust fund or separate fund shall be funded accordingly.
- 3.3. That for the consideration aforesaid, the Trustees hereby covenant with the SETTLOR, his successors and administrators that the Trustees will stand and be possessed of the existing Trust property. Trust fund upon Trust for the uses with and subject to the power, provisions, directions and agreements hereinafter declared and contained of and concerning the same.
- 3.4. That it is expressly declared that no part of the Trust fund or its property or its income shall be applied for any other purpose which is not consistent with the aims and object of the Trust and all provisions hereof shall be construed accordingly.

4. AIMS AND OBJECTS: -

Aims and objectives of the Trust are public, academic, research and general social work with particular emphasis as enumerated below: -

1. To do all acts and things calculated to facilitate the charitable, social, vocational, cultural, educational and economic services of the TRUST.
2. To promote education / general education/ school/ school from class 1 to 10 (CBSE/ICSE/BSE/students in the field of Arts/Science/Commerce/Engineering/ Medical science, Nursing, Pharmaceutical studies, Arts and crafts, Hotel management, Printing technology, Biotechnology, Food technology, Bio-sciences, establishment of Biotech parks, development of waste land, Plantation programs, Ecology, Water management, development of Tourism industry including Hotels, Airlines and Bus services, Marine sciences, Biotech industries, Information technology, Finance management, Residential school and colleges for +2,+3 and PG in different Subjects (CBSE and State pattern)/ Play School/Pre-School for children's social and economics development, cultural, housing projects for the have-nots, orphanages , run old age homes, leprosy eradication programs, rehabilitation centres, holiday home for widows, widowers , aged, helpless, publishing, printing of newspapers, periodicals magazines.
3. To provide avenues for spread of knowledge through the medium of academic courses, training, seminars, workshops, conferences, publications and exchanges of information with students, facilities and other learned bodies.
4. To give consultancy / services to the needy organisations / Government or Public sector undertakings / institutions by utilising the experts of the institutions on payment.
5. To undertake on its own and / or in affiliation / collaboration with other educational or research institutes or universities or any other organisations, educational and research for the promotion and development of technology.
6. To organise classes for imparting education and training and to hold and conduct examination or tests either by itself and / or in affiliation / collaboration with other institutes in such manner as may be considered necessary and to award certificates, diploma, etc.
7. To establish, maintain and develop libraries, reading rooms and publishing sections for publications of books, journals, magazines and booklets, etc.
8. To carry out research and development works in different fields.
9. To enter into agreement with any Government, University, Municipal or local authorities or otherwise that may be conducive to the object of the TRUST.
10. To open Hospitals, health centres and other services-oriented institutions not only to provided training facilities to the students but also providing social service to the public in general.
11. To develop literacy among the people through various educational programmes like adult education, night School, pre-schools, etc.
12. To undertake relief measures in aid of the distressed peoples affected by natural calamities or in other ways or to rehabilitate them and make them self-dependent through income generation schemes.
13. To help the unemployed youth to get skill training of different kinds i.e- kitchen gardening, food preservation, printing computer education, spinning, weaving, toy making, herbal medicine, horticulture, plant nursery, fish farming, agriculture, food technology, medicinal plants, poultry, diary farming, mushroom cultivations, etc and render vocational guidance to become self-reliant.
14. To promote information dissemination and undertake advisory services and data processing etc.

5. INTERPRETATION:

In these rules and regulation unless there be any things in the context repugnant or inconsistent therewith.

- a) "THE BOARD" means the board of management/ the Governing Body by the TRUST.
- b) A member means of member admitted as such the rules prescribed by the TRUST.
- c) Act means the Indian Trust Act 1882 Religion and Charitable Trust Act 1920.

6. TRUSTEES:

The TRUSTEE (S) of the TRUST shall consist of individual TRUSTEE (S).

- a). Such individuals who sign the Trust Deed Shall be the Founder TRUSTEES.
- b) Such other individuals who may be admitted to the TRUST from time to time and whose names are entered in the Register of TRUSTEES shall be TRUSTEE (S) of the TRUST subject to conditions that all the TRUSTEES agree to the Proposal(s).

7. VACATION OF OFFICE BY A TRUSTEE:

The office of the TRUSTEES shall be vacated in case of any of the following:

- a) If he or she dies or becomes of unsound mind.
- b) If he or she files a petition for being adjudicated as an insolvent or if he / she compounds with creditors.
- c) If without the consent of the TRUSTEES he or she remains absent from meetings of the TRUSTEES of three consecutive meetings.
- d) If he or she resigns of office of the TRUSTEE by giving in writing under his or her hand left at the principal office of the TRUST.
- e) If all the TRUSTEES decide that he or she should vacate the office of the TRUSTEE.
- f) If his or her nomination in consultation with Founder Trustee is not acceptable.

8. MEMBERSHIP FEES:

- a) All members of the First Board of the TRUSTEES except Trustee No.1 (the Settlor) shall contribute minimum amount of Rs. 5000/- towards membership fees.
- b) The new members may be admitted to the TRUST and their name shall be entered into the registered members of the TRUST and they have to contribute minimum membership fees as will be decided by the Founder Trustees.

9. FILLING OF VACANCIES IN THE OFFICE OF TRUSTEES:

Any vacancy in the office of the Trustees may be filled up after consultation and approval with the Founder Trustees.

10. MEMBER BOUND:

The TRUSTEE(S) shall be bound by the Rules and Regulation of the TRUST, by laws and decisions made or taken by the First Board/Board of TRUSTEES from time to time.

11. RECOUPMENT OF EXPENSES:

The TRUSTEES shall not be entitled to receive any salary or other remuneration for their service but shall be recouped out of the TRUST property or income thereof, all pocket expenses incurred in attending meeting of the TRUSTEES or incurred in connection with the carrying of the objective of the TRUST including Conveyance, accommodations charges, entertainment expenses honorarium and other allied expenses for fulfilment of the objectives of the TRUST.

12. MEETINGS:

- a) The Trustee shall transact their business in meetings which shall be convened from time to time as and when necessary and decided by a written circular to be issued.
- b) Four members of the trust shall form quorum.
- c) All meeting shall be chaired by the Managing Trustee or in his/her absence any other TRUSTEE amongst those present. The managing TRUSTEES in chair of the meeting shall have a casting vote.
- d) A meeting of the TRUSTEES for time being at which a quorum is present shall except as otherwise expressly provided by those presents be competent to execute and exercise by a majority of the TRUSTEES present in the meeting all powers, authorities and direction vested in the TRUSTEES under those present.
- e) In case of any difference of opinion among the TRUSTEES of the time being in any manner concerning operation of the TRUST for furtherance of its aims and objectives the opinion of majority shall prevail and be binding and conclusive.
- f) The resolutions and proceedings of any meetings of the TRUSTEES and acts done in pursuance of it be as valid as if every such person(s) has or have been duly appointed and was fit enough to be a TRUSTEE.

13. OFFICE OF THE TRUST:

The TRUST shall have the following officers:

A). THE PRESIDENT CUM-TRUSTEE

- (i) The President-Cum-Trustee shall preside over every meeting of the Trust where he is personally present and in absence of the Managing TRUSTEE the senior member TRUSTEE shall chair the meeting.
- (ii) The President of the Trust shall be a member of the governing body as decided by the majority of TRUSTEES.
- (iii) The president shall preside all meetings of Governing Body and the General Body of the TRUSTEES.

B). THE SECRETARY

- (i) The Secretary shall be responsible to the managing TRUSTEE and management TRUSTEE and shall be the officer of the TRUST and implement the decision of the Managing TRUSTEE of the TRUST and the Managing TRUSTEES.
- (ii) The Secretary shall co-ordinate the works and the programmes of the managing TRUSTEE of the TRUST and shall work as per the direction of the Managing TRUSTEES/Board of TRUSTEES.
- (iii) The Secretary shall render his assistance, as per the desire of the Managing TRUSTEE to have custody of all assets, money, movable and immovable properties, subscription and investment of the TRUST.
- (iv) The Secretary shall also exercise such power and function as the Managing TRUSTEE and Management TRUSTEES may specifically delegate from time to time.
- (v) He shall record and keep minutes of proceedings of the meetings of the TRUST as per the direction of the President/Managing TRUSTEES and after approval shall circulate to all concerned TRUSTEES for their information and vetting.
- (vi) He shall render assistance to Managing TRUSTEE to have custody and care of all documents and record of TRUST.
- (vii) He shall duly file all returns, documents, etc required to be filled with the register of the TRUST under the provision of the act with the consent of Managing TRUSTEE.
- (viii) He shall conduct correspondence for all on behalf of the TRUST unless specifically stated otherwise by the Managing TRUSTEE.

C). THE TREASURER:

- (i) The Treasurer shall oversee all sums of money received and spent by the Trust and the matter in receipt and expenditure takes place.
- (ii) The Treasurer shall oversee all sales and purchases of goods by goods by the TRUST.
- (iii) The Treasurer shall oversee the assets and liabilities of the TRUST.
- (iv) The Treasurer shall arrange annual audit of accounts duly appointed by the TRUST for the purpose.
- (v) The Treasurer shall file return of income of the TRUST with the income tax authorities as prescribe by the rules in this regard.
- (vi) The Treasurer shall keep records of all financial transactions and maintain the books as accounts.
- (vii) The Treasurer shall prepare the annual budget for the approval of TRUST.

14. NON-SECTARIAN:

The TRUST shall carry out non sectarian activities irrespective of religion caste and Creed.

15. MANAGEMENT TRUSTEES POWER:

- A) Power of Accumulation:
The Management TRUSTEE shall have the power to accumulate for a period as may be permissible in the law the whole or any part of the corpus of the TRUSTEE. The Management TRUSTEE may in their discretion as think fit invest the same as the resulting income thereof in any of the investments authorized by the law including in particular of the provision of section 11 and other provision of the income tax Act.1961 or any replacement, re-enactment or modification thereof for investments for the purpose of the TRUST applicable to the corpus of the TRUST Property shall also apply to the same and treated as one fund. Provided that the TRUSTEES accumulations at any time as if the same had been income of the TRUST Property arising in the year in which the same shall be applied.
- B) To make investments:
All money forming part of the TRUST and available for investments shall be invested in or upon any of the securities authorised by law for investment of TRUST Property.
- C) Accept Donations:
The objects of the TRUST created under these presents to be obliged only in the furtherance of such objects.
PROVIDED ALWAYS AND IT IS HEREBY AGREED AND DECLARED THAT save as otherwise expressly provided by the terms of the gift, donations or Contributions as aforesaid the TRUSTEES shall in their absolute discretion be entitled to treat such donations or contribution or any part there or for the furtherance and fulfilment of the objects of the TRUST.
- D) To make Donations:
The management TRUSTEES shall similarly power to make gifts, donations or contribution to any TRUST, Public fund or institution set up for charitable purpose which have similar objects as this Trust.

E) To deal with Properties:

- (i) To let any immovable property forming part of the TRUST Property from month to month or from year to year or for any period or in perpetuity and to sell, exchanges and purchase immovable properties upon such terms and conditions as they may in their discretion, think fit from time to time.
- (ii) To keep the movable and immovable properties forming part of the TRUST Property in good condition as fully insured and, in their discretion, to make any addition alteration and improvement to the immovable properties forming part of the TRUST property and to develop the same from time to time in such manner as they in their description deem fit and proper.
- (iii) To sell or otherwise dispose off any part of the TRUST Property on such conditions and upon such terms as the TRUSTEES in their discretion may deem fit and proper for the purpose of the TRUST.
- (iv) To accept any property whether movable or immovable before the time at which it is transferable or payable.
- (v) To secure hold improve, sell lease, covey and dispose off any property and exercise the right power and privileges of ownership.
- (vi) The Management TRUSTEES shall manage all the properties of the TRUST Prudently and Economically.

F) TO BORROW:

In their discretion to borrow raise money by way of loans from any bank, financial institutions and/or any other person or deposits by private or public appeals or in any manner permitted by law to issue promissory notes, debentures bonds or any other obligation or securities upon such terms and conditions as the Management TRUSTEES shall in their discretion deem fit and proper from time to time and to mortgage the whole or any part of the TRUST property as security of the repayment of the loans borrowed / deposit accepted for the purpose of the TRUST.

- G) To open and maintain in the name of the TRUST any Bank Account or Accounts with any Nationalized Bank or any other Banks as they shall decide from time to time and all money shall be paid in such accounts in such manner as Managing TRUSTEE(S) may decide or to authorize others to operate such accounts. Initially the Bank accounts shall be operated by any two signatories of the Management TRUSTEES approved by the TRUST Board.

H) To deal with the Trust Property:

For a Bonafede reason to appoint the TRUST Property and to compromise or compound all action, suits or other proceedings and all differences and demands and refer any such differences or demand to arbitration and to adjust, settle and approve all accounts relating to the TRUST Property and execute releases and all documents necessary in the premises and to do all other thing relating there to respectively as fully as if they were absolutely entitled to the TRUST Property and without being answerable for the loss occasioned thereby.

- I) To apply TRUST FUNDS through other charitable Trust or institution
Instead of themselves spending any sum for any purposes authorised by these present or by law statue the TRUSTEES, with sufficient reasons, may pay any sum for such purpose to any charitable educational or religious TRUST or institution without being bound to see to the application thereof.

Provided that every contribution by the TRUSTEES to any other TRUST, Society or institution, having as its objects all or any of the objects specified in clause 3 herein above shall be treated and deemed to be in furtherance and achievement of the object to the TRUST.

- J) To Manage Trust Affairs:
The affairs of the TRUST shall be managed by TRUSTEES who shall determine the purpose being charitable purpose within the objects of the TRUST as here-in-before declared for which and the manner in which the TRUST Properties shall be applied and those decisions as to any such application of the TRUST shall be final and conclusive and not open to question by any person or body.

- K) To appoint Secretary and Other Officers:
The TRUSTEES shall not be bound in any case to act personally but shall be at full liberty to appoint persons to be their secretary and/or agents etc, either on permanent basis or on contractual basis to assist them in the administration and day to day Management of the TRUST and to transact all or any business or whatever nature required to be done in pursuance of the aim and objects of the TRUST herein before declared including the receipt and payment of money and application of the TRUST Property. Any such appointment may be made for such terms and at such salaries or remuneration as may be arranged mutually.

TRUSTEES shall not be responsible for the default of any such Secretary, Officer, Worker, Agent, etc or any loss occasioned by his or her appointment. However, if the works of the Secretary or any of the Officers of the TRUST is discharged by any of the TRUSTEES their expenses like Conveyance, accommodations, telephone charges, entertainment charges shall be paid to them including the honorarium to be decided by the Board of Trustees.

- L) To make Rules and Regulations:
The TRUST shall be entitled to make a amend or rescind rules and regulations for the management of the TRUST and the TRUST property and their management including the conduct of the meeting of TRUSTEES, provided however that in all such matters, directions, if any of the Author of the TRUST shall be binding.

- M) To engage Professionals:
The TRUSTEES shall be entitled at their discretion to employ or retain professional on deputation from other organizations like I.T professionals, Chartered Accountant/s, Engineers, Legal Advisor, Medical practitioners, Valuer, for carrying out the objects of the trust or the Management thereof.

- N) To give valid discharge:
The receipt in writing of the TRUSTEES on behalf of the Trust or of Managing TRUSTEES for any interest, dividend or income or any deed, paper writing documents or other money and effect payable or deliverable by the TRUST shall be sufficient and effectual discharge for the same respectively or for so much thereof respectively as in such receipt shall be expressed or acknowledged to be or have been received and the person to whom or on whose favour the same shall be given, his, her or their heirs, executors or administrators shall not afterwards be in otherwise obliged or convened to see to application of the money, property and effects therein mentioned and acknowledge to the received or be answerable or accountable for the loss, misapplication and non-application thereof.

16. ADMINISTRATION OF TRUST PROPERTY:

The TRUST property shall be administrated and managed in accordance with the provision contained in this presents and the rules and regulations which may from time to time be framed by the TRUSTEES hereunder.

Provided however that such rules and regulations shall not offend against the object and purpose of these of these presents or be inconsistent therewith.

17. TRUST RECORDS:

All records, minute books, title deeds, securities account, books, vouchers papers and documents in relation to the TRUST shall remain in the custody of such persons and at such places as the TRUSTEES may from time to time determine.

18. INDEMNITY:

The TRUSTEES shall be indemnified out of the assets of the TRUST i.e., TRUST Property from and against all suits, proceedings, cost charges, losses, damages and expenses which they or any of them shall or may incur or sustain by reasons of any act done or committed in or about the execution of the in their respective offices, except such of them as they shall or may incur or sustain by or through their respective offices, except such of them as they shall or may incur or sustain by or through their own wilful neglect or default respectively and no such TRUSTEES shall be answerable for the act, receipts, neglect or defaults or other TRUSTEES or for solvency honestly or any member or other persons with whom any money or effects belonging to the TRUST shall be invested or any other loss or damage due to any such cause as aforesaid or which may result from Execution of this office unless the same shall happen through the wilful neglect or default of such TRUSTEE.

19. ACTION TAKEN IN GOOD FAITH:

The TRUSTEE shall not be liable for any loss to the TRUST property or TRUST premises arising by the reason of any investment made in good faith or for the negligent or fraud any agent employed by them although the employment of such agent was not strictly necessary or expedient or by reason of any mistake or omission made in good faith by any TRUSTEE here or thing except shall be liable wilful and individual fraud or strong doing on his own part.

20. FINANCIAL YEAR:

The financial year of the trust shall be reckoned 1st April each year to 31st March of the following year.

21. ACCOUNTS AND AUDIT:

Accounts of the TRUST shall be audited by a Chartered Accountant/s (auditor/s) annually. The first auditor shall be appointed by the First Management Trustees. The author of the TRUST, Secretary and Treasurers will have access to the account of the TRUST. The annual Auditor of the TRUST shall be appointed by the TRUSTEES.

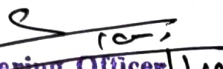

22. LEGAL ACTION:

- i) Trust may sue or be sued in the name of the Managing Trustee of the Trust in official capacity only. The legal jurisdiction shall be at Bargarh only.
- ii) Any document or proceedings of the TRUST requiring authentication may be so attested by the managing TRUSTEES.
- iii) All the documents relating to the properties of the Trust shall be executed by the Managing Trustee or the Secretary for and on behalf of the TRUST.

23. POWER TO AMEND:

- i) IT IS HEREBY EXPRESSLY AGREED AND DECLARE that the TRUSTEES Shall have the power by an unanimous resolution in that behalf to alter amend modify or terminate any of the objects and purposes of these or any other power, provision or discretion under these present which are found contrary to concept of public charitable purpose under the provision of Income Tax Act 1961, or any statutory modifications or re-enactment thereof or the provisions of any other law relating or public charities in India, without however affecting in any way the general objects and purposes of the TRUST or utilizing the TRUST Properties and the income for charitable purpose and terminate any aforesaid the same shall there after cause to be applicable but without prejudice to the right of the TRUSTEES by similar unanimous resolution to restore any such objects or purpose power or provision either in the original form or with such modification there to as the TRUSTEES any consistently with the provision of this clause determine.
- ii) The founder TRUSTEE of the TRUST has every right to design the alteration within the provisions of the act mentioned above such decision and design of alteration is final.

24. TERMINATION OF TRUST:

On being intimated by the First Board/ Board of TRUSTEES of the TRUST that it is desirable to terminate the TRUST or for some other reason, the TRUSTEES may cause termination of the TRUST by passing an unanimous resolution about dissolution of the TRUST. On termination no part of the TRUST property shall be paid to or applied for the benefit of any private individual and all assets remaining after paying or adequately providing for the debts and obligations of the TRUST shall be conveyed, transferred and assigned to the similar type of TRUST or to the Government.
